She also oversaw a comprehensive review of energy regulations. Jill also previously held the position of Deputy Counsel at the Republican National Committee, where she handled state and federal election law and party rules matters. Following the 2000 election, Jill represented the Bush-Cheney campaign as counsel in West Palm Beach and Osceola County during the Florida Presidential Recount. Jill served as staff counsel for the 1996 Republican National Convention in San Diego, California.

In 2007, Jill was elected to the Senate of Virginia, where she represented the 27th Senate district for 16 years.
